To advise the various facets of the work on Zoonoses in the state and list Zoonoses infection/diseases according to priority and importance under the various heads like bacterial, viral, fungal, parasite and protocol to enable the scientists in the field to tackle the problem on a priority basis.

2. To formulate the terms of reference and modus operandi for developing the networking between various sectors viz. medical, veterinary and allied institutions.

3. To advise regarding the location and requirement of special laboratories at the national or regional level for preparation of special diagnostic reagents, diagnosis of selected Zoonotic diseases and identification of isolates.

4. To formulate projects with detailed technical programme for effective and meaningful work on priority problems.
