In the interest of public service and in partial modification of this Department's Notification even No. dt. 20.6. 2006 the Governor of Mizoram is pleased to constitute the Village Level Tam Endiktu Pawl Committee consisting of the following members with immediate effect.

| 5) Headmaster, Govt. High/Middle School of the Village, In case of village where no Govt. High/Middle School exist, Headmaster, Govt. Primary School of the Village. | — Member Secretary |
| 6) Inspector/Sub-Inspector/Store keeper under FCS&CA if posted at the village | — Ex-officio Members |
| 7) President or his representative of political parties viz.-MNF, INC, ZNP MPC and MCP Unit. | Member. |

The function of the village level Tam (Famine) Endiktu Pawl shall be as follows :-

- 1) The Committee shall ensure that nobody dies due to starvation under their jurisdiction.



2) The Committee shall prepare detail economic status of each every household under its jurisdiction by visiting every house. The report is to be submitted to the Director, Food, Civil Supplies & Consumer Affairs with copies to District and Block Level Tam Endiktu pawl.

3) The Committee is empowered to issue rice on credit to old aged persons, sick and very poor persons who do not have supporter in the family.

If such issue of rice is made. the Committee shall submit details report to District Level Tam Endiktu pawl houses a week to assess their status.

4) The Committee shall ensure that there is not unauthorised eiversion, unauthorised sale of rice by officials, Drivers and Carriage Contractors in the village and enroute. If such sale or issue, detail report shall be submitted to Director, Food, Civil Supplies & Consumer Affairs for taking corrective necessary action.

5) Decision of the Committee it to be made in full sitting of the Committee. Decision and resolution, so passed shall be forwarded to higher authority.

Individual member's proposal or recommendation shall not be entertained.

6) Any proposal, recommendation and suggestion shall be routed through Block Level and District Level Tam Endiktu Pawl.
