The Governor of Mizoram is also pleased to order that placement or fitment of the above named Judicial Officers in the respective grades of the Mizoram Judicial Service shall be subject to the Hon'ble Gauhati High Court's decision on the pending representations submitted either for different placement or fitment or for inclusion in the list, and the same shall not affect the pay-scales, presently allowed to them until otherwise decided by the Hon'ble High Court.

The Governor of Mizoram is further pleased to order that consequent on their absorption or induction in the Mizoram Judicial Service and their services having been placed by the Hon'ble High Court at the disposal of this State Government under sub-rule (3) of the Rule 6 of the Mizoram Judicial Service Rules, 2006 the Judicial Officers at Sl. No. 1, 10, 12 and 13 in the list above shall be treated to be on deputation to this State Government, until repatriated back from their respective posts.

This issues in compliance of the Hon'ble Supreme Court's order dt. 09.5.2007 in the W.P. (C) no. 1022 of 1989 (All India Judges Association & Ors. Vs. Union of India & Ors).
