NOTIFICATION

No.G.28014/54/2006-PLG, the 17th May, 2007. As per provision of Article 243 ZD of the Indian constitution, the Governor of Mizoram is pleased to constitute Aizawl District Planning Committee to prepare draft Developmental Plan for the District as a whole with immediate effect and until further order.

The Aizawl District Planning Committee shall, in preparing the draft Developmental Plan, have regard to:

- i) Matters of common interests including spatial planning, sharing of water and other physical and natural resources, the integrated development of infrastructure and environment conservation.
- ii) The extent and type of available resources whether financial or otherwise.
- iii) and consult such institutions and organization as the Governor may, by order, specify.

The chairperson of Aizawl District Planning Committee shall forward the Developmental Plan, as recommended by such Committee, to the Secretary, Planning & Programme Implementation, Govt. of Mizoram.

The District Plan exercise should be started each year well ahead of the State Plan exercise, so that the State Plan can be built upon the basis of the District Plans. The preparation of the District Plans, therefore, should be initiated in the month of May every year.
