### TERMS & REFERENCE :

Core Committee can discuss and develop work plans on HIV/AIDS main streaming the work plan can include the following type of objectives:—

- Training of Labour Department Officials/Factory Inspectors on HIV/AIDS. This would enable them to appreciate HIV/AIDS as labour issue and include it in their advisory functions.

- b) Meetings with Industry Associations/Enterprises and encourage them to start HIV/AIDS Programmes for their employees. The Committee will make a list of key enterprises and public and private sectors have meetings with them and encourage them to develop HIV/AIDS workplace policy and programmes for their employees/families and the communities around them.
- c) Meetings with Trade Unions/Sensitization Programmes for Unions so that they could integrate HIV/AIDS in their existing programmes in partnership with the management respective SACS.
- d) Integrated HIV/AIDS in the activities of the Labour Welfare Boards to reach out to worker in the informal economy. This can be done in partnership with SACS and Civil Society Organization.
- e) The Core Committee can meet periodically to review the implementation of the work plans.
