## NOTIFICATION

No. G. 28014/54/2006-PLG, the 17th May, 2007. As per provision of Article 243-ZD of the Indian Constitution, the Governor of Mizoram is pleased to constitute KOLASIB DISTRICT PLANNING COMMITTEE to prepare draft developmental plan for the District as a whole with immediate effect and until further order.

The KOLASIB DISTRICT PLANNING COMMITTEE shall, in preparing the draft developmental plan, have regard to:

- I) Matters of common interest including spatial planning, sharing of water and other physical and natural resources, the integrated development of infrastructure and environment conservation.
- II) The extent and type of available resources whether financial or otherwise.
- III) And consult such institutions and organizations as the Governor may, by order, specify.
