The MAMIT DISTRICT PLANNING COMMITTEE shall, in preparing the draft developmental plan have regard to:

- i) matters of common interest including spatial planning, sharing of water and other physical and natural resources, the integrated development of infrastructure and environmental conservation.
- ii) the extent and type of available resources whether financial or otherwise.
- iii) consultation of such institution and organization as the Governor may, by order, specify.

The Chairman of MAMIT DISTRICT PLANNING COMMITTEE shall forward the developmental Plan, as recommended by such Committee to the Secretary, Planning & Programme Implementation, Govt. of Mizoram.

The District Plan exercise should be started in the month of May each year so that the State Plan can be built up on the basis of the District Plans.
