THE LUSHAI HILLS DISTRICT (VILLAGE COUNCILS)
(AMENDMENT) ORDINANCE, 2006.

ORDINANCE No. 1 of 2006

Promulgated by the Governor of Mizoram on the Fifty-Seventh year of Republic of India

An ordinance

to further amend the Lushai Hills District (Village Councils) Act, 1953
(hereinafter referred to as the Principal Act)

WHEREAS the Mizoram Legislative Assembly is not in session and the Governor is satisfied that circumstances exist which render it necessary for him to take immediate action.

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 213 of the Constitution, the Governor of Mizoram is pleased to promulgate the following Ordinance, namely :-

| 1. <i>Short Title, Extent and Commencement</i> | <ol style="list-style-type: none"> 1) This Ordinance shall be called the Lushai Hills District (Village Councils) (Amendment) Ordinance, 2006. 2) It shall have the like extent as the Principal Act. 3) It shall come into force at once. |
| 2. <i>Amendment of Section 3</i> | <p>In sub section (2) of section 3 of the Principal Act, for clauses (i), (ii), (iii), (iv) and (v), the following clauses shall be substituted, namely :</p> <ol style="list-style-type: none"> (i) For Village not exceeding 200 houses, there shall be 3 (three) members; (ii) For Village with more than 200 houses, but not exceeding 500 houses there shall be 4 (four) members; (iii) For Village with more than 500 houses, but not exceeding 800 houses, there shall be 5 (five) members; (iv) For Village with more than 800 houses, there shall be 6 (six) members. |
